The Resource person had also narrated the importance of the different Health Insurance as a comprehensive plan, designed to protect the artisans and their family against expenses incurred in case of hospitalization. They explained in details about the various Health Insurance Scheme like Pradhan Mantri Jeevan Bima Yojana, Pradhan Mantri Suraksha Bima Yojana and Atal Pension Yojana.

Sri Banajit Talukdar, Chairperson of the organisation encourages the artisans and expressed to the participants the need to channelize the traditionally inclined activities of the local people to organise themselves for better marketing and production. It thus aims at creating active participation and commitment to achieve in their activities so as to establish as an organized sector with establishing production-cum-training centre of cottage industries for the development and promotion of
